



Information on REACH und RoHS

REACH Regulation (EC) No. 1907/2006

Feinmetall GmbH has dealt intensively with the obligations arising from the REACH Regulation and has implemented appropriate measures to ensure conformity. In particular, we have also contractually obliged our suppliers to comply with the relevant requirements and to provide the necessary information.

Substances of very high concern (SVHC list)

According to Article 33 of the REACH Regulation, we have the obligation to inform if a so-called substance of very high concern (SVHC) is present in a concentration > 0.1% in one of the components of an article. The list of these substances is published by the European Chemicals Agency and can be accessed here:

RoHS Directive 2011/65/EU incl. Directive 2015/863

According to Annex II of the RoHS Directive, the following substances may not be present in electrical equipment and its components as such or above the threshold in homogeneous material:

- Lead (0.1%)
- Mercury (0.1%)
- Cadmium (0.01%)
- Hexavalent chromium (0.1%)
- Polybrominated biphenyls (PBB) (0.1%)
- Polybrominated diphenyl ethers (PBDE) (0,1%)
- Di(2-ethylhexyl) phthalate (DEHP) (0,1 %)
- Butylbenzylphthalate (BBP) (0,1 %)
- Dibutylphthalate (DBP) (0,1 %)
- Diisobutylphthalate (DIBP) (0,1 %)

We confirm the compliance of our products with the listed substance restrictions according to the RoHS Directive Annex II.

For individual products, the following exceptions according to Annex III of the Directive apply.

- 6a.I: Lead as an alloying element in steel for machining purposes and in galvanized steel containing up to 0,35 % lead by weight
- 6c: Copper alloy containing up to 4 % lead by weight
